NOTIFICATION

Sub: Extension of the scheme "Chief Minister's Scheme for Reimbursement of Interest to MSMEs" (CM-SRIM).

Ref: MSME Department Notification No. 6010/ MSME dated 21.08.2023 and No. 7946/ MSME dated 06.11.2023.

- (1) The Chief Minister's Scheme for Reimbursement of Interest to MSMEs (CM-SRIM) was launched by Government of Odisha under which manufacturing MSMEs of Odisha, which commenced commercial production on or before 31.03.2020, were entitled for reimbursement of interest on Working Capital loan availed from Banks in FY 2023-24.
- (2) Now, Government of Odisha in MSME Department has decided to extend aforesaid scheme i.e. "Chief Minister's Scheme for Reimbursement of Interest to MSMEs (CM-SRIM)" for a further period of 04 (four) years commencing from the FY 2024-25 to FY 2027-28.
- (3) The detailed operational guideline (Amendment) in this regard will be issued shortly.


