#### **CORRIGENDUM**

No.MSME-P&B-P&B-0017-2023 9675/MSME, Bhubaneswar, Dated the 21.11.2025

Sub: Detailed Operational Guidelines for Chief Minister's Scheme for Reimbursement of Interest to MSMEs (CM-SRIM) for the Period 2024-25 To 2027-28.

In partial modification to this Department Notification No. 8954/MSME dated 27.10.2025, on the detailed operational guidelines issued in respect of CM-SRIM, the guidelines mentioned against the point number(s) indicated below may be read as under and the rest all remains unaltered.

**Point No. 3 (e)** The unit will be eligible for reimbursement of interest for Working Capital Loan availed from only one bank and that too for only one loan account for the same period.

If the unit has already availed benefit of interest reimbursement on Working Capital Loan or any similar benefit for the current financial year (i.e. during which claim has been applied for) under any other scheme of the State Government or Central Government, it shall be eligible for the differential amount of benefit only.

#### Illustration 3:

If the MSME unit has availed Working Capital Loan (in form of CC/EPC) from more than one bank for separate time periods falling within the six monthly claim period, the unit will be eligible for scheme benefit fully. For example, if an MSME has availed CC/EPC loan from one bank for the period 01.04.2025 to 31.07.2025 and from another bank for the period 01.08.2025 to 30.09.2025, then it will be eligible to claim reimbursement of interest paid to both banks.

But, if an MSME has availed CC/EPC loan from more than one bank for the same/overlapping time period, then it will be eligible to claim, as per its choice, reimbursement of interest paid to only one bank.

**Point No. 3 (f)** If the Working Capital Loan account of the unit maintained in the bank becomes NPA, the unit shall become ineligible to get benefit under this scheme from the date its loan account becomes NPA.

**Point No. 04 (c)** Similarly, the second claim period of the same FY shall be from 1<sup>st</sup> October to 31<sup>st</sup> March and the claim application must be filed by 30<sup>th</sup> June of the next year. If the claim is found to be alright, reimbursement shall be made by 31<sup>st</sup> August of the next year.
